

Rolling 10-year total return difference: value vs growth



- With very few exceptions, no company visits or meetings with senior management (Maj will not be "talked into" an investment)
- No consideration of analyst estimates (they are notoriously inaccurate)
- No factor-based investing (too restrictive)
- Maj Invest integrate Environmental, Social and Governance (ESG) factors in the investment and decision-making process to better manage risks


